Present Research Projects

1. Japanese Foreign Aid – Where is It Heading?

This is a project that researches Japanese ODA from various perspectives. Major changes are going on in this field in global society. We have a number of new donor countries such as China, India, South Africa and Brazil. There are also a number of new private donors such as Bill Gates or Warren Buffett. At the same time other financial flows have increased so that ODA to a certain extent has become irrelevant. Where is Japan's foreign aid placed in all this? What purpose does it fulfil, who gets it and what kind of projects is Japan supporting? This is a project focusing mainly on developments during the last ten years and the increased securitization that is ongoing in the field of aid in Japan as well as on a global level. It is also my aim to sum up the research I have been doing on Japanese foreign aid during the last two decades. In December 2011 I conducted field studies in Tanzania for this project, in January 2012 I carried out field studies on Japanese ODA to South Sudan and in March 2013 I conducted field studies in Myanmar. During 2014 I presented papers on the revision of the Japanese ODA charter in Trondheim, Norway and in Berlin, Germany. I also participated in a panel at the conference organized by JICA in Tokyo in Nov. 2014 to celebrate the 60-years anniversary on Japanese foreign aid. In October 2015 I organized an international workshop in Stockholm and in November another one in Osaka discussing foreign aid after 2015. A new research group on Japanese ODA has been created at Osaka University. October 2016 I conducted field research of Japanese development cooperation in the Philippines. Nov 17-18

2016 a workshop with the title "A Changing Aid Paradigm Development Cooperation Pivoting to Asia" was organised together with Stockholm University. In February 2017 I conducted field research on Japanese ODA in Ethiopia. Part of this research was presented in the book "Japanese Development Cooperation The making of an aid architecture pivoting to Asia", edited by Andre Asplund and Marie Söderberg and published by Routledge 2017.

2. Japan–EU Relations

As chairperson of EJARN (the European-Japan Advanced Research Network) I am continuously involved in ongoing research on relations between the EU and Japan. On 4–5 June 2009 an international workshop titled 'EU-Japan Action Plan' was organized in Stockholm. On 2 December 2009, a symposium was organized in Tokyo, during the Swedish presidency of the EU Council of Ministers, entitled 'EU-Japan Relations in the Years Ahead - Something New or More of the Same?' (Together with Keio University). The Japanese group of "wise persons" appointed by the Ministry of Foreign Affairs at this symposium met with their colleagues from EJARN to debate the future of Japanese–European relations. On 9 February 2010 I acted as a moderator and chairperson for the session on *Joint Leadership* on Global Challenges at the symposium 'Japan and European Union' organized by the European Commission in Brussels. On 10–11 June 2010 EJARN organized another workshop in Stockholm to debate EU–Japan relations. On 9–10 June 2011 an international workshop focusing on EU-Japan trade issues was held in Stockholm, with sponsorship from the Toshiba Foundation. On 14–15 June 2012 another international workshop on EU–Japan relations, again with sponsorship from the Toshiba Foundation, was held in Stockholm. On June 24-25 2013 a third workshop on the same theme was held in Paris. I am the editor (together with Paul Midford) of, as well as a contributor to, Japan Forum, Vol. 24, Issue 3 2012, Special Issue: EU–Japan Relations (published by Taylor & Francis in London). On November 25 2013, I presented the paper 'Promoting Peace-Building through EU-Japanese Cooperation in ODA' at the conference Japan and EU: Living together in a multipolar world arranged by TEPSA, KU LEUVEN, ULB, Waseda, ICU and the EU-Japan Centre in Brussels. The conference was held at the University Foundation in Brussels and featured a mixture of academics and high level EU officials such as the Chief Operating Officer of the European External Action Service Mr David O'Sullivan, Mauro Petriccione, chief negotiator of DG trade, European Commission and H.E. Kojiro Shiojiri, Ambassador and head of the Mission of Japan to the EU. March 10 2014 Friends of Europe and Jica in Brussels organized the high level conference 'EU-Japan ready for a New Stage in Relations?' Marie Söderberg spoke in session II 'Working together on the Democracy, Human Security and Resilience'. In November 2014 I was lecturing on EU-Japan economic relations in Tokyo. On Nov 21, 2014 the Japan Forum on International Relations and the Ministry of Foreign Affairs of Japan organized an international symposium in Tokyo titled 'Japan and Europe: Creating Together a Better Future - Rule Based and Prosperous'. MS participated in the panel 'Japan and Europe Cooperation – What are their Respective Mutual Advantage and How Should We Use Them for a Better Future?'

In March 2015 I organized a conference on EU-Japan trade at Stockholm School of Economic. The EU Trade Commissionaire Cecilia Malmström participated and so did the chief negotiators on the EU side Mauro Petriccione as well as the chief negotiators on the Japanese side H. E. Mr. Yasumasa Nagamine.

In June 2015 EJARN organised a conference on EU-Japan relations at University of Pavia in Italy, June 2016 another one at Warwick in the UK and in June 2017 in Frankfurt. Marie Söderberg is one of the eitors of a book on EU-Japan relations published in 2019. On September 28 the EU Trade Commissionaire Cecilia Malmström held a seminar at EIJS

explaining the new Free Trade/Economic Partnership Agreement which was then signed on 8 December 2017. In 2020 EIJS also organised a webinar with the now former EU Trade Commissionaire Cecilia Malmström talking about the economic partnership agreement. MS keeps giving talks and is publishing on the Strategic Partnership Agreement between EU and Japan.

3. The Nexus of Security and Development: Opportunities and Prospects for EU–Japan Cooperation

What have the EU and Japan together done and achieved globally in terms of bilateral nonmilitary security cooperation, where are there problems and obstacles, and how could these problems and obstacles be overcome to increase 'on-the-ground' cooperation? What are the prospects for more intense global EU–Japan non-combat security cooperation in strife-prone regions and who and what could stand in the way of such increased cooperation? The purpose of this project, which is a joint undertaking of EJARN and the Konrad Adenauer Foundation (KAS), is to receive and pool input and knowledge from both scholars and practitioners in order to be able to assess where the EU and Japan can and cannot expand onthe-ground cooperation in the areas of peace building, post-conflict reconstruction, and development aid in conflict zones such as Afghanistan, and secondarily Mindanao, Sudan, East Timor, Sri Lanka, Burma and others. A first workshop was held in Berlin in September 2011. Papers from this workshop have been edited into a publication. A second conference on the same theme was held in Tokyo on 21 February 2012 in cooperation with both KAS and the Japan International Cooperation Agency (Jica) and a third in Brussels on 30-31 May 2012. A publication with policy proposals titled 'EU-Japan Cooperation in the Nexus of Security and Development' was published in 2012. February 13, 2013 Marie Söderberg presented EJARN's policy proposals for to the European Delegation in Tokyo. This was the official presentation of the printed version of the recommendations that now have been distributed in both Tokyo and Brussels. Among the other speakers at the meeting were Alojz Peterle, Member of the European Parliament and former Prime Minister of Slovenia, as well as Japanese House of Councillors members Kuniko Inoguchi (LDP) and Misako Yasui (DPJ). An update of the old study is being done and another conference was arranged by EJARN and KAS in Tokyo on Nov 2 2017. A third Tokyo conference was arranged by EJARN and KAS on September 13 2018 and a forth one in November 2019. A policy brief built on contribution to the 2019 conference will be published within short.
